The Department of Commerce has organised a One-day workshop on Intellectual Property Rights for all students (Degree) on 14-12-2017.

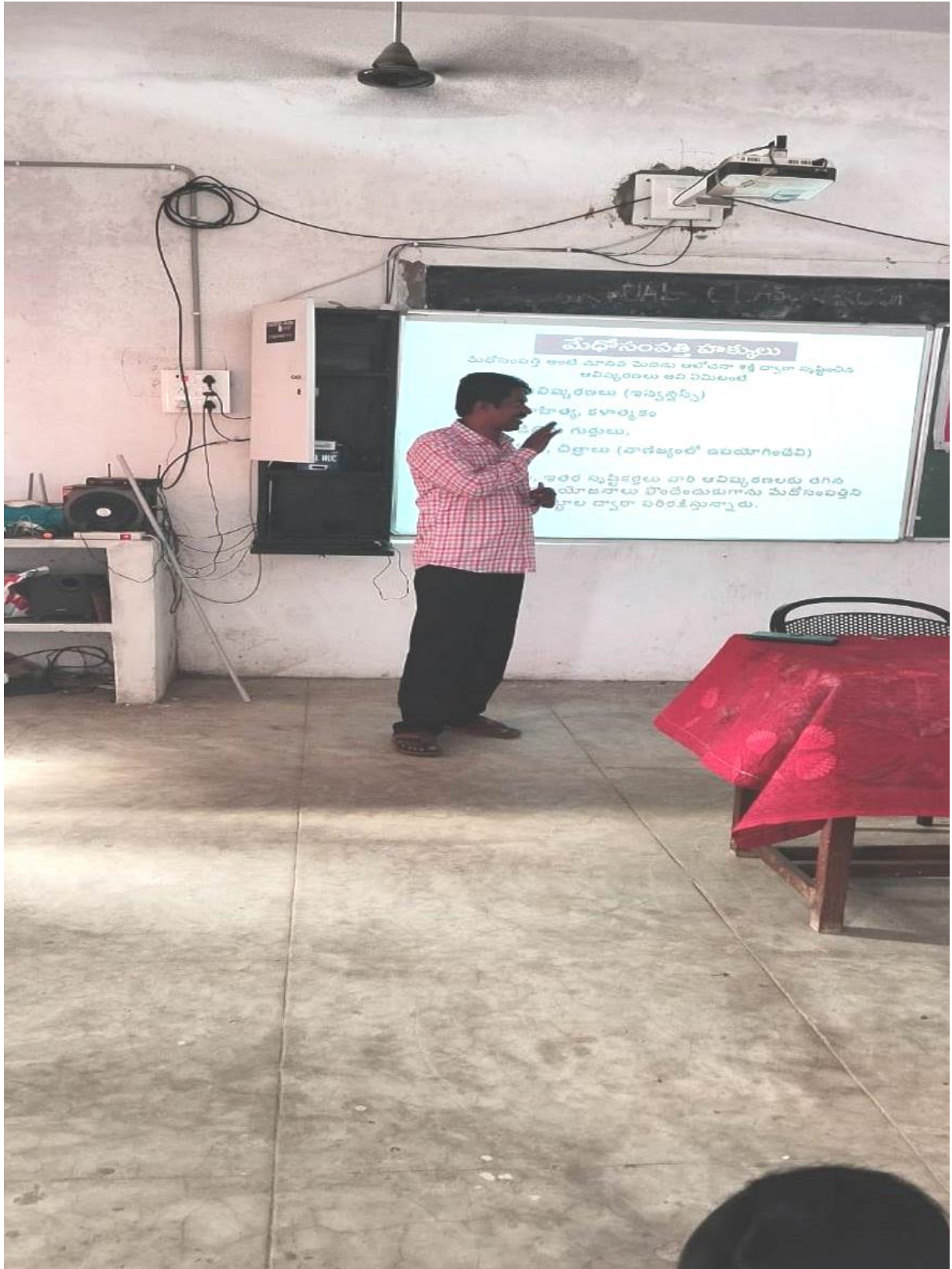
OBJECTIVES:

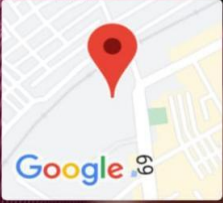
Objectives:

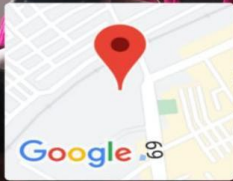
Outcomes of the programme:
